teams along with collaborating within a small EHS team based on other sites.

Working predominantly independently at our Hull manufacturing facility, with responsibility for key EHS elements such as site Environmental and Safety Management systems, Environmental permit and ISO14001 compliance, Chemical management, operational assessments, training, audits and inspections.
