Work with the region to secure higher data quality in particular for Scope 3 data.

Support digitalization of our carbon footprint. Secure customer requirements for annual reporting of qualitative and quantitative environmental data to a high standard – eg: CDP, NQC.

Liase with procurement on annual renewable electricity requirements for customers.

Contribute carbon expertise to ongoing projects, such as tracking progress towards DP world carbon neutrality goals.

Empower the QEHS regional teams by creating an environment that promotes positive communication, encourages collaboration and demonstrates flexibility.

Participation and administration of Integrated Management Systems audits for ISO 14001 and ISO 50001.

Design and develop best practice environmental procedures, ensuring these procedures are understood and implemented regionally.

Develop and maintain environmental emergency preparedness and response processes.

Provide specialist guidance for Environmental induction for all employees.

Working with the operational teams to improve the environmental performance, reducing the impacts to the environment from operational activities.

Conducting internal environmental audits, work place inspections and environmental tours to the prescribed frequency.

Responsible for environmental legal compliance audits- activities including record keeping and follow up.

Responsible for maintaining a corporate register for environmental legal compliance in the region and communication of changes to environmental laws across the region.

Environmental incident / accident investigation coordination including record keeping of conclusions, actions & follow up.

Chairing environmental meetings, presenting data, recording actions and maintaining the progress on the actions.

Monitor & report country and site environmental performance to local and country management

and external interested parties eg: CDP.
