Establishing positive relationships and providing unconditional support.

Helping children and young people address difficulties and achieve their potential.

Acting as a key worker to ensure care plans are followed and amended as needed.

Providing emotional support during challenging times.

Supporting educational PEEP and extracurricular activities.

Empowering children and young people to actively participate in decision-making.

Collaborating with colleagues to achieve shared objectives.

Adhering to policies and procedures to maintain a safe and nurturing environment.

Continuous development is integral to the team culture, and additional responsibilities may arise to meet evolving needs. Staff members are expected to work flexibly within their level of responsibility.
